## 6. **Other business**

Points raised by attendees included:

- Whether people who have moved into the village recently could be encouraged to join the WhatsApp volunteers' group;
- Free events were successful, and it was good that some events could be funded from surpluses at paid events;
- The optimum level of reserves: some events had relatively high level of up-front costs;
- Whether other projects could be funded such as a play area. The purchase of some equipment was being considered including a cadac;
- St David's Day: a funding request had been made. Some events being considered could run without funding.
